1. TREASURER'S REPORT

Outstanding Balance (Savings): \$12,746

2. PICNIC

- The annual neighborhood picnic will be held the 3rd weekend in September: Saturday (9/17)

- The first Picnic Committee meeting will be held two weeks after the newsletter is sent out
 - Newsletter to be sent on 7/9/11
- 2010 Budget: \$750 + donations
- 2011 Budget: \$1000

3. **NEWSLETTER**

- Newsletter has been drafted and reviewed; to be sent out on 7/9/11
- Tom Malysz will make copies at Kinko's
- Highlights:
 - Vicki Gladstone is running the "Neighborhood Watch" program
 - A Babysitting Club is getting started per recent requests

4. OUTSTANDING ASSOCIATION DUES

- To date, there are 17 association homes that have outstanding dues
 - Due collection status is a little below average for this time of year
 - 7 of the homes have outstanding leans

5. RENTERS ISSUE

- During the April 2011 Annual Association Meeting, a homeowner expressed concerns with a neighboring house that had been rented out to a number of tenants. Assistance with the matter was requested from the board.
- The Board looked into the homeowner's request and learned that the landlord of the property had recently issued a court order to remove the renters; however, the Court denied eviction of the tenants.

6. **NEW NEIGHBORS**

- The Board has decided that all new neighbors should receive a neighborhood directory
- Welcome gifts are not sent out to new neighbors at this time

7. NEIGHBORHOOD DIRECTORY

- The current directory is out of date
- Consider referencing the Association Bylaws and Deed Restrictions within the back of the directory; at least direct homeowners to the Association website so they made view the documents online

8. NEW MARKER LANDSCAPING

- The new landscaping around the two neighborhood markers has been completed as budgeted
- The landscaping was completed in June due to the rainy Spring season; as a result, the flower selection was limited

9. TRI-FOLD MACHINE

- The Board voted on the decision of whether or not to invest in a Tri-Fold Machine to assist with folding newsletters and other various Association publications
- Prices were researched and it was determined that a budget of \$150 would be needed
- Final vote for allocating \$150 towards the purchase of a tri-fold machine:

In Favor: 5Opposed: 1Abstained: 0

The motion passed; Pete Arango was assigned the task of making the purchase

10. NEW IDEAS
