### **Trailer Parking PSA**

Did you know that our Deed Restrictions prohibit keeping campers and trailers on our property? Under the Deed Restrictions, Part C: #14.c states: "House trailers, mobile homes, motor homes, campers, boats, canoes, snowmobiles, trailers of any kind or commercial vehicles shall not be stored or parked on any lot except within a private attached garage." The City of Rochester Hills allows trailer and RV parking on the street in front of your house for up to 72 hours to maintain and prepare them for use, however they are not allowed to be connected to sewer, gas, water or electrical facilities. The City also prohibits inhabiting them while parked. We understand the efforts to maintain your equipment can be time consuming and laborious, and hope you will respect your friends and neighbors by abiding by our rules and the City Ordinance.
